Membership Categories and Fees (as at 1 July 2024)

Category	Details	Cost
<b>7 Day</b>	Has unrestricted access to social and competition golf Monday to Sunday, subject to tee time availability and unrestricted entitlement to all the social privileges of the Club. Social rounds will require payment of a member's green fee of \$6 (set by the Board).	\$995 p.a. Joining Fee \$250
<b>6 Day</b>	Has the same privileges as a 7 Day member but is not permitted to play in the Saturday competition.	\$855 p.a. Joining Fee \$250
<b>Colt</b>	A Colt member must be aged under 25 years as at 1 July and has the same playing privileges as a 7 Day member.	\$215 p.a. Joining Fee \$50
<b>Junior</b>	A Junior member is aged under 18 as at 1 July and will pay a discounted subscription plus insurance and affiliation as set by the Board for every member.	\$115 p.a. Joining Fee \$50
<b>Country</b>	Member must provide evidence that they permanently live 80km or more from the Club for more than 3 months in any one calendar year. A Country Playing Member has unrestricted entitlement to all the social privileges and practice facilities of the Club Mon to Sun but is restricted to access to the golf course to a maximum of 12 rounds (competition or social rounds at member prices) per year.	\$416 p.a. Joining Fee \$50 (No pro rata option available for this category)

Social membership benefits include access to the clubhouse facilities and no golf privileges. The Annual subscription is \$25 per annum and a separate form exists for this category of membership.
